- All children must complete an enrolment form in order to book.
- Registered care for childcare subsidy.
- Bring along each day: a hat, water bottle, jumper and a spare change of clothes.

Fee Payment : Cancellation of care will not be accepted after the 25th June. I acknowledge that once I make my booking for vacation care that I am not entitled to any refunds or credits, should I cancel my child/rens bookings (except under extreme/extenuating circumstances on application to the Nominated Supervisor). Where possible, ‘swapping’ of days will be accommodated. I agree fees will be charged for the days my child is booked into the centre, including times when my child is absent due to illness. The fees for vacation care will be charged on the 25th June 2018.

Bus Travel: I consent to allow my child to travel to and from excursions identified with “bus travel” on their enrolled days by the centre mini bus.

Walking to excursion: I consent to allow my child to walk to and from excursions identified with “walking” on their enrolled days supervised by First Learning Staff.

Illness, incident and emergency treatment authorisation: In the event of an emergency, illness or incident concerning my child (and the staff of First Learning Australia, being unable to contact me or other persons authorised by me), I hereby consent to First Learning Australia seeking and authorising the carrying out, on my behalf, of any medical, dental, hospital or ambulance attention for my child and I accept liability for any and all expenses as may be incurred.

Medication: In the event that my child suffers from a temperature over 38°C, I give permission for the staff to administer Panadol using the prescribed dosage on the bottle. I understand that I will still be notified and required to collect my child from the centre within the hour.

Photographs: Photographs are a wonderful way of observing and recording children’s special moments. Accordingly, I agree for photographs being taken of my child for recording and observation purposes for displays in the centre, newsletters and other communication with parents. No photos will be shared on any social media without additional consent.

Direct Debits: Childcare fees will be deducted from the nominated account each Thursday. A \$30 administration charge will be added to your account for each Direct Debit dishonored. If this occurs more than two consecutive times, First Learning Australia will have the right to terminate care effective immediately.
